Capitol Quarter Midgets Association is excited to offer the use of a race ready quarter midget to a selected family for the 2021 CQMA racing season.

Terms Of Agreement

- 1) Recipient must be a member of USAC and must comply with membership requirements as set forth by USAC including insurance fees and annual dues.
- 2) Recipient must be a full member of CQMA and comply with membership requirements and code of conduct, including weekly entry fees, track duties and club dues.
- 3) Recipient must agree to participant in at least 75% of CQMA club race events in 2021 season and may be used in MWT at CQMA and Tri City Series events. Car shall not be used in any other USAC sanctioned event without CQMA board approval.
- 4) Missing 3 or more consecutive events will revoke this agreement and the car shall be returned to CQMA.
- 5) Recipient is responsible to purchase the necessary approved safety equipment for scholarship driver as mandated by USAC .25
- 6) Recipient must be able to transport car to and from events at CQMA safely and securely and be able to securely store car between races in enclosed storage.

- 7) Recipient must pay a \$200 refundable deposit upon receipt of car. Deposit shall not be refunded if car is not returned by track closure of scholarship awarding season 2021.
- 8) Recipient shall be liable for weekly preventative maintenance of car, including oil changes and routine cleaning. Failure to adhere will result in forfeiture of deposit.
- 9) Recipient shall be liable for replacing damaged, bent or broken parts that may occur during the racing season. Including nerf bars, radius rods worn tires etc. Failure to adhere will result in forfeiture of deposit
- 10) No modifications or alterations may be made to the decaling, or paint of car. The previous are to be maintained in original condition at time of initial receipt of car.
- 11) Recipient driver and car will initially be restricted to the rookie class. Upon the approval of the CQMA board, the car may be used in progressive classes as set forth by USAC, including age and weight restrictions.
- 12) Recipient will agree to bring car and assist with any Driver Experience events, as well as any promotional CQMA events held at the track. Recipient will NOT be held liable for damages that may occur at Driver Experience events.
- 13) Recipient is liable for any injuries leading to medical evaluation and or treatment incurred during participation and should also have private or public medical insurance for recipient driver.
- 14) CQMA will reserve the right to at any time revoke the agreement and will pursue necessary means and measures to ensure return of any and all CQMA property established during this agreement.
- 15) Upon full agreement, recipient will be awarded the use of race ready quarter midget for 2021 racing season.
